Please read the schedule carefully

Artist Membership must be renewed before submitting work.

All forms require to be completed before handing in work and a separate form is required for each art work. These plus your Data Protection form must be printed and the handwriting legible.

Artist Member Entrants	£15 to submit a maximum of 3 art works plus an additional 2 small paintings at £2 per painting (£19 max). (a small painting is 16" x 16" or smaller)
Open Entrants	£15 to submit a maximum of 2 art works.

Cash or Cheque must be brought with you at time of submission. Please note that submission fees are non refundable.

There is no size restriction on work submitted other than the small painting prize, which is 16"x16".

Sales - Artists will be notified of work sold and a commission of 35% will be charged on their work.

Additional information for submission of work.

We request that work is not sent by post.

There are different hanging systems used in the Galleries so we ask that split rings, but no cord, are attached to mounted work. All other works should have no hooks or rings attached. Work should be suitably presented for the exhibition, no MDF, no metal or clip frames. All works framed or unframed should be strong enough to take screw-in hooks.



Sculptors must supply a plinth with their work. The use of plinths and the display and location of sculpture/3D work will be at the discretion of the hanging team. Plinths supplied by entrants will not be used with other work without the permission of the entrant.

If artists have downloaded labels and will be delivering by courier please put all completed labels and data protection forms in a SAE and attach securely to the back of work. Labels will be attached at submission point. **Please have your title, name and address on the back of your work regardless of which type of label you use.**

The decision of the selection panel is final and no correspondence will be entered into regarding the selection of work.
